1. The workload is sanctioned on the basis of grant-in-aid faculty, division and subjects.
2. The workload shown faculty wise, division wise and subject wise by the college according to the student strength. The strength shown in the proposal must be on the college rolls and should not mismatch.
3. For calculation of the workload, the maximum student strength which is mandatory should on be considered.
4. It is mandatory to maintain student strength for practical batches as per the norms of government.
5. Classes allotted for lectures, practical, tutorials, and project work should be according to the norms of government.
6. It is mandatory for the college to maintain Roaster for recruitment as per the reservation norms of government and the Roaster must be certified by the competent authority.
7. In the next year, if there is any decrease in the workload on the basis of student strength there will be decrease in the no. of posts sanctioned.
8. The process of recruitment should not be carried out without pre-approval of the government. If there is any recruitment without approval of the government. It will not be considered for sanction of grant in such cones the college and the Management will be held responsible.
9. This is the letter of sanction of posts only, for recruitment of the sanctioned posts in this letter standard operating procedure of the government should be followed. The college has to apply independently to the government for N.O.C. for recruitment.
